

1. **ALL HUNTERS AND FISHERMEN MUST FIRST CREATE AN ACCOUNT AT <https://ftbenning.isportsman.net/>**

- From the homepage select the **REGISTER** tab
- Create a username and password and enter personal information. Click continue and then complete account set-up
- Enter only *correct and accurate* information
- Fill out *all required* fields

2. **AFTER YOU HAVE CREATED AN ACCOUNT AND LOGGED IN....**

- ****IMPORTANT**** When you purchase your permit a waiver/hold harmless agreement will be presented for you to **READ**, date and sign. **YOU MUST ENTER THE DATE YOU WANT YOUR PERMIT TO START** at the top of the waiver/hold harmless agreement (can be up to 30 days in advance). Your permit will be valid starting on the date you select and **CANNOT BE CHANGED** afterwards.
- If you *only intend to fish* then select the **AVAILABLE PERMITS** or **ACQUIRED PERMITS** button and follow all prompts to purchase your appropriate Post Fishing Permit.
- If you *intend to hunt* you must complete the Fort Benning Specific Hunting Safety Brief
 - Select **My Safety Brief** and follow all prompts to view the video and confirm completion
 - After completion of the Safety Brief select the **AVAILABLE PERMITS** or **ACQUIRED PERMITS** button and follow all prompts to purchase your appropriate Post Hunting or Combination Permit.

3. **AFTER PURCHASING YOUR POST PERMIT(S) YOU WILL NEED YOUR PERMIT AND VEHICLE ACCESS PASS**

4. **ALL PERMITS AND VEHICLE ACCESS PASSES MUST BE VALIDATED. RECREATIONAL USERS ARE NOT ALLOWED TO GO AFIELD UNTIL THEY HAVE COMPLETED AN IN-PERSON CREDENTIALS AND VALIDATION CHECK AND THEIR PERMIT HAS BEEN STAMPED!**

- Credentials and validation check will **ONLY** be conducted at **DFMWR Outdoor Recreation, the Recreational Shooting Complex, and Uchee Creek County Store during regularly scheduled business hours**. Users **MUST** plan accordingly!
- **ALL** users **MUST** present a valid IN and hunters must present proof of completion of a State Certified Hunter Education Course in order to demonstrate they are authorized to possess the Post Permit they purchased

- **ALL** family members, guest hunters, and/or their Sponsor must present a signed Family Member Guest Affidavit which can be printed from the Regulation Tab on the iSportsman Homepage
- **ALL** Guest Permits will have the Sponsor's name and permit number manually added to the permit by MWR personnel during the credentials check

5. ONCE YOUR PERMIT HAS BEEN VALIDATED WITH A STAMP, YOU MAY GO AFIELD IN ACCORDANCE WITH FB REGULATION 200-1 AND MCoE REGULATION 190-11

6. NOTE: EFFECTIVE 15 JUNE 2017, ALL RECREATIONAL ACCESS WILL BE MANAGED THROUGH iSPORTSMAN. HUNTERS WILL BE REQUIRED TO CHECKIN TO AND OUT OF TRAINING AREAS AND RECORD HARVEST GAME VIA iSPORTSMAN
